- NOT the spouse of a Minister or an Assistant Minister licenced to the parish.
- NOT engaged as an employee paid from the funds of the parish.

### Warden:

- Common eligibility criteria for all positions; AND
- NOT the spouse of another serving Warden or Parish Councillor.

### Parish Councillor

- Common eligibility criteria for all positions; AND
- NOT the spouse of another serving Warden or Parish Councillor.

### Parish Nominator

- Common eligibility criteria for all positions; AND
- A lay person; AND
- Have attained the age of 21 years old; AND
- NOT the spouse of another serving Parish Nominator.
