- Common eligibility criteria for all positions AND
- NOT the spouse of another concurrently serving Warden or Parish Councillor

#### Parish Nominator

- Common eligibility criteria for all positions AND
- A lay person AND
- Have attained the age of 21 years old AND
- NOT the spouse of another concurrently serving Parish Nominator
