- NOT been convicted of a disqualifying offence listed in Schedule 2 of the Child Protection (Working with Children) Act 2012

### Additional criteria:

#### Warden:

- NOT the spouse of a Minister licenced to the parish
- NOT the spouse of another concurrently serving Warden
- NOT engaged as an employee paid from the funds of the parish

#### **Parish Nominator:**

- Have attained the age of 21 years old
- NOT engaged as an employee paid from the funds of the parish
- NOT the spouse of another concurrently serving Parish Nominator
- NOT an immediate family member of a person employed from the funds of the parish
